A study of servant leadership, leadership accountability, and reliance on God in one's personal life and ministry. Emphasis is given to applying teambuilding and change processes in ministry contexts.

- 1. Evaluate leadership styles and development strategies for faithful fruitfulness
- 2. Explain the relationship of biblical and theological foundations to the theory and practice of Christian leadership
- 3. Employ sound leadership principles to plan for change and growth in a ministry setting
- 4. Equip believers to serve and grow in partnership with their leaders and each other All instruction, activities, and assessments in this class will relate to one or more of these course objectives.

V. Assignments

Instructor will provide details concerning rubrics, formatting, submission, and due dates.

Core Assignments (Required):

1. Instructional Exercises (30 points each, 450 points total – Objectives 1, 2, 3, 4)

Description: Students will reflect upon the textbook and course instruction, practice the techniques taught, and utilize the tools taught.

Requirements: Instructors will assign the equivalent of 15 relevant exercises of 250-400 words or approximately 1 hour each.

- ✓ Summaries and reflections upon the assigned textbook reading
- ☑ Online discussion board posts (include responses in the word count)
- ☑ Reading, listening to, or watching and reflecting on relevant articles, chapters, videos,

Instructors will provide details on formatting, submission, and due date.

Instructors may consider requiring students to submit, share, or present their weekly exercises at the following class meeting.

Submissions will be graded both for quality and for demonstrated familiarity with the textbook and/or class instruction.

Approximate Course Load: 15 Hours Total

2. Leadership Philosophy and Strategy Paper (300 points – Objective 2)

Description: Students will implement the truths, tools, and techniques explained in this course to write a paper explaining their philosophy of Christian leadership and their strategy for ongoing personal leadership development. This paper will be 2,400-3,600 words (8-12 pages if formatting according to the *Midwestern Style Manual*) and will include the following sections: *1. Introduction and Definition of 'Christian Leadership'* (100-150 words), *2. Explanation and Defense of Definition* (1,800-2,400 words), *3. Strategy for Ongoing Personal Leadership Development* (300-900 words), and *4. Conclusion* (100-150 words). Instructors will inform students of any more detailed requirements (e.g., sub-sections within Section 2).

At least 6 appropriate academic sources are required, and at least 10 biblical references (with appropriate explanation) are required. Submission/Presentation: Instructors will provide details on formatting, submission, and due date. Additionally, Instructors may require students to present their papers to the class.

Approximate Course Load: 15 Hours

Approximate Course Load from Core Assignments: 30 Hours Total Core Assignment Points: 750

Instructors will require specific assignments to fulfill the remaining course load hours for the class track.

Assignment Type

1. Reading Reflections (100 points each; 200 points total – Objectives Vary)

Description: Students will read and reflect upon one or more books from Appendix 1, as assigned by the instructor.

Requirements: Students will reflect upon each work in 900-1,500 words (3-5 pages if formatting according to the *Midwestern Style Manual*). Reflections will include 1. A summary of the book's contents (450-900 words), 2. An evaluation of the book's point(s) and argument(s) (300-500 words), and 3. The student's plan to apply the book's truths to his or her life and ministry (150-300 words).

Course Load: 15 hrs each - 30 hrs Total

2. Ministry Strategy Prospectus (200 points – Objectives 2, 3)

Description: Students will implement the truths, tools, and techniques explained in this course to outline a strategy for a particular ministry program or project in a stated ministry context, including biblical and theological foundations and practical organizational application. To complete this assignment, students do not need to implement the ministry project or program for which they have created a strategy. However, students may implement the strategy as part of the Ministry Portfolio assignment (if applicable).

Requirements: This prospectus will be 2,400-3,600 words (8-12 pages if formatting according to the *Midwestern Style Manual*). Instructors will inform students of any more detailed requirements (e.g., sections, subsections, and formatting). Papers will include the following sections: *I. Introduction/Overview* (100-150 words), *2. Vision/Mission/Values of this Project/Program with Explanations* (300-450 words), *3. Demonstration of the Need for this Project/Program* (300-450 words), *4. Structure and Strategy of this Project/Program* (450-600 words), *5. Explanation of the Resources Required for this Project/Program, including finances, materials, space, skills, personnel, etc.* (150-300 words), 6. *Biblical and Theological Foundations for this Project/Program* (at least three; 1,000-1,500 words total), and *5. Conclusion/Summary* (100-150 words).

Submission/Presentation: Instructors will provide details on formatting, submission, and due date. Additionally, instructors may require students to present and discuss their prospectuses in class.

Course Load: 10 Hours

3. Ministry Portfolio (20 points each hour (300 pts total) – Objectives 3, 4)

Description: Students will participate in some form of ministry that directly relates to one or more of the objectives of this course. Instructors should have an intimate understanding of the student's responsibilities and workload.

Requirements: Students will submit sufficient evidence of this field work in the form of a portfolio, including at least 1,500 words of explanation and reflection (formatting and exact requirements to be determined by the instructor). Portfolios might include elements such as lesson plans, video links, sermon manuscripts, meeting agendas, etc.

Assignment Options: Appropriate field work for this course will include activities acting as or assisting a leader in any relevant role in a church or para-church ministry.

Submission/Presentation: Instructors will provide details on formatting, submission, and due date. Additionally, Instructors may require students to present their portfolios to the class. Grading: Instructors will complete an overall evaluation of the student's portfolio, found in Appendix 2.

Course Load: Ministry hours assigned (10 hrs) plus approximately 5 hours for reflection and compilation. Total Hours: 15
