

10 Reasons to OPPOSE Pro-Abortion Amendment 3

1 Parental Consent laws will be eliminated

If a "right" to abortion is enshrined in our Missouri Constitution it would allow abortions to be performed on pregnant minors without notice to or consent from the minor's parents.

2 Abortion - all 9 months

If our Missouri Constitution is amended with a "right" to abortion, abortion will be allowed for "physical or mental health" for all 9 months from conception to live birth.

3 No alternatives allowed

This amendment callously disregards the unborn child and the alternatives to sacrificing his/her life and future while helping his/her mother.

4 Health & Safety standards eliminated

Missouri health and safety standards for abortion clinics would be gutted if this amendment passes. Its language would even allow some unlicensed persons to perform or induce abortions.

MO's pro-life laws will be eliminated

Our Missouri Constitution is our state's supreme (highest) law and governing document. Our pro-life laws in more than sixty sections of the Revised Statutes of Missouri will be eliminated by enshrining a "right" to abortion in our Missouri Constitution.

Women lose ability to sue for malpractice

A woman's ability to seek criminal prosecution/civil penalty of any person who performs/assists/provides support to induce/

seek/obtain an abortion will be eliminated.

AMENDMENT 5

- OSAGE RIVER CASINO

Amendment 5 would allow the operation of a new casino near the Lake of the Ozarks. State revenues from the operation of the casino would be earmarked for early-childhood literacy programs

Problems with this amendment:

- · It creates pathways for addiction and harm to families.
- The casino would need to generate a 31% increase in tax revenue for the lake area to match ballot language predictions. This is wildly unrealistic.
- The way that revenues would be used is unclear. While it promises help for "early-childhood literacy," it is not defined who will receive those funds, or how they will be spent.
- · It invites the entire state to make a decision that could deeply harm the local community at Lake of the Ozarks.

A NO vote on Amendment 5 is best for all Missourians.

HARMS

MEN & THEIR **FAMILIES**

Gambling affects all people in ways that grieve the heart of God, but men are especially vulnerable.

Consider:

· The average gambling debt of a man addicted to gambling is between \$55,000 and \$90,000.



- · This debt comes with increased rates of job loss, home loss, legal trouble, and damage to family relationships.
- · 58% of men who gamble say that sports betting has negatively affected their mental

While gambling addiction affects people from all walks of life, studies show that black men, single men, and men under 30 are at higher risk of this destructive practice.

AMENDMENT 2

-SPORTS BETTING

Amendment 2 would legalize betting on professional sports in Missouri. If passed, Missourians could place such bets online, in casinos, or within professional sports arenas. Tax revenues from such gambling activity would be designated for education and compulsive gambling prevention programs.

Online betting is lining the pockets of platform creators while hurting American families.

When the Supreme Court struck down the Professional and Amateur Sports Protection Act in 2018, it opened the floodgates to placing bets online and through gaming apps.

Gross revenues from sports gambling increased from \$430 million in 2018 to more than \$11 billion in 2023.

Online betting is more addictive than other forms of gambling.

Gambling addiction risk rose 30% in the first three years since the Supreme Court made sports betting legal. This addiction is fueled by:

- · Gamblers' mistaken assumption that sports knowledge gives them a way to beat the odds.
- Live betting giving gamblers the ability to bet many times during a game, reducing the delay between risk and reward.

Problems with this amendment:

- · It enables legal access to a new, incredibly virulent form of gambling.
- · It brings sports betting into the home, workplace, and schools.
- It increases the reach of sports betting platforms without solving age-verification problems that allow minors to participate.
- · Losses may be greater since betting is tied directly to bank accounts.
- · It endangers the integrity of sports.

A NO vote on Amendment 2 helps keep the pandemic of gambling in check.

2024 REPORT

At NAMB, it's all about the gospel, and we are here to serve and support pastors and churches as they minister on the front lines of pushing back lostness. Our more than 6,600 missionaries and chaplains were discipled, raised up and called out from local Southern Baptist churches, and we are grateful for each one of them. Thank you for giving to the Annie Armstrong Easter Offering® and the Cooperative Program.

Here are some highlights of how God is working through our partnership with Southern Baptists:

Our Evangelism Team is seeing great engagement from churches. In 2023 more than 10,000 copies of NAMB's new Evangelism Kit were distributed to churches. The kit is designed to help pastors create a culture of evangelism in their church that will endure even as programs and emphases come and go. We had the opportunity to train more than 1,300 pastors and ministry leaders who plan to implement the training in their churches. Our Refresh Retreats give ministry leaders a chance to be equipped, encouraged and re-energized, and in 2023 we were able to provide this experience for more than 1,200 pastors and their wives. Since launching our Youth Leader Coaching Network in 2021, more than 800 youth leaders have attended the in-person gatherings, and more than 1,500 youth leaders have participated in the online sessions. Our Collegiate Coaching Network launched in the spring of 2022, and since then has had more than 260 collegiate leaders participate in the in-person gatherings and more than 400 engaged through the online sessions. Both networks equip leaders to engage students in evangelism, discipleship and missions.

Send Network, our church planting arm, is helping Southern Baptists start new churches everywhere for everyone. In 2023, we celebrated as Southern Baptists surpassed more than 10,000 new churches started since 2010, an incredible testimony to God's faithfulness and the Great Commission commitment our churches have. Under Vance Pitman's leadership, more than 400 church planters attended Send Network orientation at NAMB in 2023. In addition, we hosted five **Send Network Gatherings** throughout North America where church planters and their wives received training, coaching and encouragement as they met with fellow planting couples and Send Network leaders. Also in 2023, we launched the new **Mobilization Pathway** which helps churches take their next step in church planting.

Send Relief, the compassion ministry we lead in collaboration with the International Mission Board, is meeting immediate needs for thousands of people while also pointing them to salvation in Christ. In North America, Send Relief engaged more than 33,000 volunteers from more than 3,300 churches in 2023. We also added new resources designed to help churches start and sustain gospel-centered compassion ministries in their local communities. Send Relief has launched seven new video courses as part of its **Church Guide to Ministry**, with expert practitioners in each of their respective fields. We have also cultivated a network of **Affiliate Ministry Centers** over the last year, allowing Send Relief to walk alongside other like-minded ministries in the hope of elevating their presence and sharing their best practices as they seek to serve their communities and resource SBC churches.

NAMB-endorsed Southern Baptist Chaplains number more than 3,300 as they serve and minister all over the globe, reaching people that churches often cannot access. This includes more than 1,100 military chaplains who serve men and women in the United States Armed Services stationed on military bases throughout the world. In addition to endorsing chaplains on behalf of Southern Baptists, NAMB **provides training, resources and encouragement** to chaplains serving in hospitals, prisons, in disaster settings, law enforcement and as first responders. In 2023, Southern Baptist chaplains presented the gospel 95,627 times, resulting in 18,408 professions of faith and more than 1,600 baptisms.

Thank you, Southern Baptists, for the privilege to serve you and to partner with you in taking the gospel to North America.


